LLB (Hons) Law, Media & Creative Industries



Solicitor

Provides legal advice to clients, drafts legal documents, negotiates, and represents clients in noncourt matters. Specialises in areas such as family, corporate, or property law.

Advocate Solicitor

A solicitor with additional accreditation to represent clients in higher courts. Combines skills of a solicitor and barrister.

Barrister

Specialist advocate representing clients in court. Provides expert legal opinions and appears in tribunals and higher courts.

Chartered Legal Executive

A qualified lawyer specialising in a specific area of law. Often works alongside solicitors and barristers but follows a different qualification route.

Paralegal

Supports lawyers by conducting research, preparing documents, and assisting with casework. Often a step toward becoming a solicitor.

Court Legal Adviser

Provides legal advice to magistrates and judges to ensure proper legal procedures are followed during court proceedings.

Legal Secretary

Supports legal professionals by preparing documents, managing correspondence, and organising legal files.

Legal Assistant

Provides administrative and casework support to legal teams, helping with research, documentation, and client communication.

Facilitates negotiations to help parties resolve disputes without going to court. Common in family, commercial, and employment disputes.

Judge

Presides over court proceedings, interprets the law, and delivers judgments to ensure fair trials.

Notary Public

Authenticates documents and oversees the signing of important legal documents for international or official use.

Arbitrator

Resolves disputes outside of court through arbitration, often used in commercial and international legal matters.

In-House Counsel

A lawyer employed within a company to provide legal advice on contracts, compliance, and risk management.



Enforcement &

Public Safety

Police Officer

Enforces the law, investigates crimes, and ensures public safety. Law graduates may join through fast-track leadership schemes.

Detective

Specialises in investigating serious crimes such as fraud, homicide, or cybercrime.

Works with offenders to reduce reoffending and help them reintegrate into society while ensuring they comply with court orders.



NGO Worker (Legal Officer)

Works for charities or NGOs on issues such as human rights, environmental law, or immigration law.

Represents the UK in international relations, negotiating treaties, and advising on foreign policy

Civil Servant (Policy Advisor)

Develops, advises, and implements public policies in areas like justice, immigration, or international law.

Human Rights Advocate

Protects individuals' rights by working with human rights organisations and advising on compliance with international law.

Legal Compliance Officer

Ensures organisations comply with laws and regulations, commonly in industries like finance, healthcare, or corporate governance.

Immigration Officer

Assesses visa and asylum applications, ensuring compliance with immigration laws.



Law Professor

Teaches law at university, conducts research, and publishes legal papers.

Legal Researcher

Conducts in-depth research on legal issues to support cases, academic work, or policy development.

Academia and Education

Legal Consultant

Provides expert legal advice to organisations on specialised areas such as environmental law or intellectual property.

Legal Translator

Translates legal documents between languages, ensuring legal accuracy in international contexts.



Corporate Governance Officer

Advises companies on compliance with corporate laws and governance practices.

Risk Manager

Identifies and mitigates legal risks within organisations, ensuring compliance with laws and regulations.

Human Resources Manager

Manages employment law issues such as contracts, equality, and disciplinary matters within organisations.

Drafts, reviews, and manages contracts to protect a company's legal interests.

Social Media Manager

Planning, creating and managing social media content to help organisation/businesses to achieve goals.

Curators

Responsible for selecting, organising, and managing collections of art, artifacts, or specimens, ensuring that they are displayed and interpreted effectively by the public.

Museum Personnel

Encompasses a range of roles dedicated to the day-to-day operations of a museum, including administration, visitor services, and support for exhibitions and programmes.

Site Management

Oversees operations and maintenance of historical or archaeological sites, ensuring preservation, safety, and engagement for visitors while managing staff and resources.

Education Officers

Develops and implements educational programmes and resources for museums or cultural institutions, aiming to engage diverse audiences.

Archivist

Organises, preserves, and manages historical documents and artifacts for public access.

Heritage Manager

Oversees preservation and promotion of cultural heritage sites to ensure their historical significance is maintained.

Historian

Researches and interprets historical events and artefacts to provide context and insights for museum exhibits.

Academic Researcher

Conducts in-depth studies on historical topics to contribute valuable knowledge to museum collections and displays.

Librarian

Manages and organises museum libraries to ensure access to historical books, documents, and resources.

Media Researcher

Investigates and gathers multimedia content related to heritage to support museum exhibitions.

Political Analyst

Examines historical political events and their impact to provide analysis for museum displays.

Creates engaging content about historical topics, crafting narratives for museum exhibits, publications, and educational resources.
