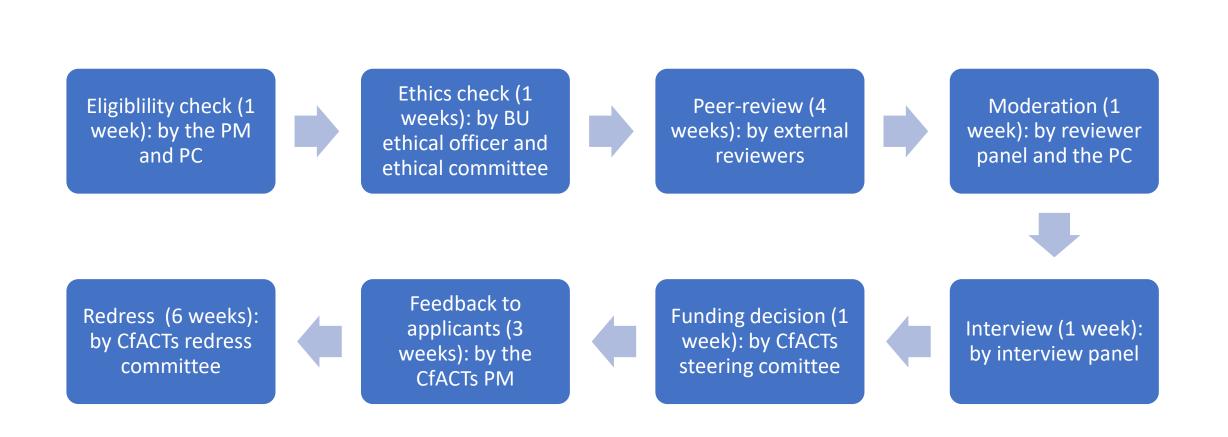

Selection Process



Eligibility

To be eligible to apply an applicant must :

- Be in possession of a doctorate or have at least four years fulltime equivalent research experience.
- Not have resided or carried out his/her main activity (work, studies, etc.) in the United Kingdom for more than 12 months in the three years immediately before the call deadline.

Application Process- Template



- All application forms must be in English. A completed application consists of:
- Part A Administrative information
- Part B1 Research Proposal (max. 10 pages);
- Part B2 Applicant CV (max. 5 pages);
- Part C Ethics issues Applicants must provide information on how they intend to address potential ethics issues, as required by the Horizon 2020 Guidance on Ethics Self-Assessment;
- Part D (Optional) Signed support letters from the applicants PhD academic supervisors;
- **Part E** Signed Data Protection Consent Form;
- **Part F** Criminal Records Declaration;
- Part G BU Equality Monitoring Form.

Overview of Selection Process



- The scores for eligible applications will be collated and the applications with the highest score (e.g. top 9 for each call) and pass the selection criteria will be invited to attend an interview.
- The interview will be conducted via video conference. The interview panel will score the performance of, and provide their recommendation for, each candidate.
- Funding decision: the CfACTs steering committee will meet to discuss the final funding decision based on the review score and interview panel's recommendation.

Selection Process – Peer Review

• Scoring:

- Scoring must be in the range from 0-5. Decimal-marks may be given.
- **0** Proposal fails to address the criterion or cannot be assessed due to missing or incomplete information.
- 1 Poor. The criterion is inadequately addressed, or there are serious inherent weaknesses.
- **2** Fair. Proposal broadly addresses the criterion, but there are significant weaknesses.
- 3 Good. Proposal addresses the criterion well, but a number of shortcomings are present.
- 4 Very Good. Proposal addresses the criterion very well, but a small number of shortcomings are present.
- 5 Excellent. Proposal successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.

Selection Process – Peer Review Panel



• **The overall threshold**, applying to the weighted sum of the 3 individual scores, is 70/100. Proposals with scores below this will be rejected with feedback in writing.

Overall Score	Proposal quality	
< 50/100	The quality of the proposal is poor with serious inherent weakness.	
	The project is not in a fundable state.	
50/100~70/100	There are major flaws in the proposal and the narrative is not clear.	
	The project is not in a fundable state.	
70/100 ~ 90/100	The proposal is with good quality. There exist some small issues	
	and concerns to address. The project is likely to be recommended	
	to receive funding.	
>= 90/100	The proposal demonstrated excellence in research and training. The	
	fellow has strong profile to conduct the research. The project is	
	highly recommended to receive funding.	

Score calculation: For example, if a proposal scored 4.0 for excellence and 3.5 for impact and 3.1 for implementation, the score will be calculated as: 4/5*50%+3.5/5*30%+3.1/5*20% = 73.4/100.
